This seventh edition cancels and replaces the sixth edition published in 2017. This edition constitutes a technical revision.

This edition includes the following significant technical changes with respect to the previous edition:

- a) the text has been aligned with IEC 60335-1:2020;
- b) some notes have been converted to normative text, modified or deleted (Clause 1, 7.1, 7.15, 11.4, 13.3, 21.101, 22.101, 27.2, 30.101);
- c) conciliation of the text of IEC 60335-2-36 with other standards under IEC/TC61/MT32;
- d) exclusion of battery-operated appliances and appliances used in areas open to the public (Clause 1);
- e) relocation of cleaning instructions from 7.12.1 to 7.12;
- f) clarification of the testing procedure in 15.1.1;
- g) clarification on the test conditions in 19.1 and 23.3;
- h) introduction of 22.110;
- i) clarifications in the requirements in 25.3.

This Part 2 supplements or modifies the corresponding clauses in IEC 60335-1, so as to convert that publication into the IEC standard: Particular requirements for commercial electric cooking ranges, ovens, hobs and hob elements.

When a particular subclause of Part 1 is not mentioned in this Part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification" or "replacement", the relevant text in Part 1 is to be adapted accordingly.

NOTE 2 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, etc.

NOTE 3 The following print types are used:

- requirements: in roman type;
- *test specifications: in italic type;*
- notes: in small roman type.

Words in **bold** in the text are defined in Clause 3. When a definition concerns an adjective, the adjective and the associated noun are also in bold.

INTRODUCTION

It has been assumed in the drafting of this International Standard that the execution of its provisions is entrusted to appropriately qualified and experienced persons.

This information is given for the convenience of users of this International Standard and does not constitute a replacement for the normative text in this standard.

This standard recognizes the internationally accepted level of protection against hazards such as electrical, mechanical, thermal, fire and radiation of appliances when operated as in normal use taking into account the manufacturer's instructions. It also covers abnormal situations that can be expected in practice and takes into account the way in which electromagnetic phenomena can affect the safe operation of appliances.

This standard takes into account the requirements of IEC 60364 as far as possible so that there is compatibility with the wiring rules when the appliance is connected to the supply mains. However, national wiring rules may differ.

If an appliance within the scope of this standard also incorporates functions that are covered by another Part 2 of IEC 60335, the relevant Part 2 is applied to each function separately, as far as is reasonable. If applicable, the influence of one function on the other is taken into account.

When a Part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the Part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal ~~and generic standards~~ publications, basic safety publications and group safety publications covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. ~~For example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces, are not applicable in addition to Part 1 or part 2 standards.~~ **1**

An appliance that complies with the text of this standard will not necessarily be considered to comply with the safety principles of the standard if, when examined and tested, it is found to have other features that impair the level of safety covered by these requirements.

An appliance employing materials or having forms of construction differing from those detailed in the requirements of this standard may be examined and tested according to the intent of the requirements and, if found to be substantially equivalent, may be considered to comply with the standard.

NOTE 3 Standards dealing with non-safety aspects of household appliances are:

- IEC standards published by TC 59 concerning methods for measuring performance;
- CISPR 11, CISPR 14-1 and relevant IEC 61000-3 series standards concerning electromagnetic emissions;
- CISPR 14-2 concerning electromagnetic immunity;
- IEC standards published by TC 111 concerning environmental matters. **1**

HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES – SAFETY –

Part 2-36: Particular requirements for commercial electric cooking ranges, ovens, hobs and hob elements

1 Scope

This clause of Part 1 is replaced by the following.

This part of IEC 60335 deals with the safety of electrically operated commercial **cooking and baking ranges**, ovens, **hobs, hob elements** and similar appliances ~~not intended for household and similar use~~, their **rated voltage** being not more than 250 V for single-phase appliances connected between one phase and neutral and 480 V for other appliances.

~~NOTE 101~~—These appliances are **not intended for household and similar purposes**. They are used for commercial processing of food in areas **not open to the public** **2**, for example in kitchens of restaurants, canteens, hospitals and in commercial enterprises such as bakeries, and butcheries, ~~etc.~~

The electrical part of appliances making use of other forms of energy is also within the scope of this standard.

As far as is practicable, this standard deals with the common hazards presented by these types of appliances.

~~NOTE 102~~—Attention is drawn to the fact that

- for appliances intended to be used in vehicles or on board ships or aircraft, additional requirements ~~may~~ **can** be necessary;
- in many countries additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labour, the national water supply authorities and similar authorities;
- in many countries, additional requirements are specified for pressure appliances.

~~NOTE 103~~—This standard does not apply to

- appliances designed exclusively for industrial purposes;
- appliances intended to be used in locations where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas);
- appliances for continuous mass production of food;
- steam cookers, forced and steam convection ovens (IEC 60335-2-42);
- ~~hot cupboards (IEC 60335-2-49);~~
- appliances for keeping food and crockery warm (IEC 60335-2-49);
- commercial microwave ovens (IEC 60335-2-90);
- **battery-operated appliances. 3**

 - 2 Appliances intended for household use or use in areas open to the public are not covered by this Part 2 Standard.
 - 3 Battery-operated appliances are not anticipated for the appliances covered by this Part 2 Standard.
 - 4 This is modified to align with other Part 2 Standards for commercial catering equipment.
 - 5 This is relocated from 7.12.1 to 7.12 because it is not related to installation instructions.
 - 6 This is now covered by 5.21 of IEC 60335-1:2020.
 - 7 Test parameters are added to 10.2 for appliances rated in current. The test parameters are based on those in 10.1.
 - 8 Clarification of the testing procedure regarding the position of adjustable feet and positioning the apparatus so that it is not splashing on the bottom of the appliance.
 - 9 Clarification on the test conditions regarding setting of controls or switching devices to achieve the most unfavourable condition.
 - 10 This additional test in the Part 1 is suitable for lightweight portable heating appliances, but it is not necessary for commercial catering equipment.
 - 11 This revision is for alignment with IEC 60335-1:2020 and other Part 2 Standards for commercial catering equipment.
